Recitals

- A. The intellectual property identified in the schedule to this deed will hereinafter be referred to as **The Intellectual Property**.
- B. Craig, Gray and Erikson are employees of EHP.
- C. Craig, Gray and Erikson in the course and scope of their employment with EHP, are the co-designers and co-authors of the designs the subject of the design application listed in Part A in the schedule to this deed.
- D. Craig and Gray in the course of their employment with EHP are the authors of drawings, computer images and or electronic representations which depict the designs the subject of the design applications listed in Part A in the schedule to this deed.
- E. Craig, Gray and Erikson will be referred to collectively as The Assignors.
- F. The Assignors each wish to confirm that any right, title and interest they have in respect of The Intellectual Property, was owned by EHP at the time of filing of the applications listed in the schedule to this deed.
- G. In the event that the Assignors have any right, title and interest in The Intellectual Property pursuant to recital F above, the assignors each wish to assign to EHP that right, title and interest in The Intellectual Property, including any right to claim convention priority and the right to file applications for patents, designs, utility models, registration of copyright

or any other intellectual property in respect of The Intellectual Property, in any country or jurisdiction, together with all common law and intellectual property rights therein including but not limited to copyright, free from all encumbrances.

This deed witnesses

that in consideration of, among other things, the payment by EHP to each of the Assignors of AU\$1, the receipt and sufficiency of which is acknowledged, the parties agree:

1 Assignment

- (a) The Assignors assign to EHP:
 - (1) all of the Assignors' interest in The Intellectual Property; and
 - (2) the right to sue for damages and other remedies in respect of any infringement of The Intellectual Property which may have occurred before this assignment.
- (b) This assignment is effective on 21 September 2006.

2 Assignors' warranties

2.1 General

The Assignors give the warranties in this clause 2 to EHP.

2.2 Original creations

The artistic works described in the schedule to this deed are original creations of Craig and Gray.

2.3 Entitled to deal

The Assignors are entitled to assign The Intellectual Property in the manner provided in this deed.

3 Assignor's acknowledgments

The Assignors acknowledge that:

- (a) EHP may alter or vary the artistic works described in the schedule to this deed in any manner without the Assignor's consent;
- (b) EHP may use or apply the artistic works referred to in clause 3((a)) without any attribution of authorship; and
- (c) this assignment is not limited to particular versions of artistic works or to designs in any particular colour.

4 Registering this assignment and further action

- (a) EHP must pay any fees or costs in relation to registering this assignment.
- (b) The Assignors must execute any documents and do any other things that EHP reasonably requests to:
 - (1) enable EHP to have its ownership of The Intellectual Property registered in any appropriate registry;
 - (2) enable EHP to file or prosecute in its name any application for a patent or design registration or other registration forming part of or relating to The Intellectual Property, whether in Australia or in any other country; and
 - (3) give effect to the terms of this deed.

5 Assignors' undertakings

The Assignors must not:

- (a) challenge or oppose, or assist a person to challenge or oppose, any application by EHP for a patent or other registration forming part of or relating to The Intellectual Property, whether in Australia or in any other country;
- (b) assist any other person in challenging or impugning the validity of:
 - (1) The Intellectual Property; or
 - (2) a patent, design or other registration granted to EHP relating to The Intellectual Property; or
- (c) take any other action to invalidate, put in dispute or impair in any way EHP's interest in or use or exploitation of The Intellectual Property.

6 Assignors must deliver materials

The Assignors must deliver to EHP on request all artistic works, designs, certificates, title documents, technical information and records relating to The Intellectual Property.

7 General

- (a) A variation of the terms of this deed must be in writing and signed by the parties.
- (b) In this deed, unless the context otherwise requires:
 - (1) words importing the singular include the plural and vice versa;
 - (2) a reference to a person includes a corporation; and
 - (3) a reference to a person includes that person's successors and legal personal representatives.
