John Petro and Jane Clayton hereby certify that:

1. They are, respectively, the President and Secretary of Quizix, Inc., a California corporation.

2. Article FIRST of the Articles of Incorporation of said corporation is amended to read as follows:

"The name of this corporation is **NovaTorque, Inc.**"

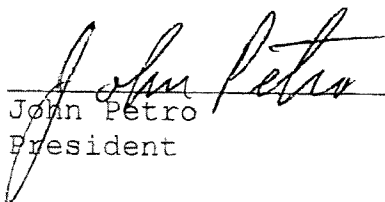
3. The Board of Directors of Quizix, Inc. has approved the foregoing amendment to the Articles of Incorporation of said corporation.

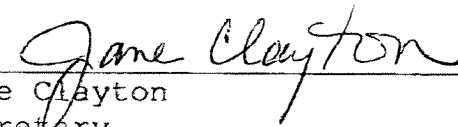
4. The foregoing amendment was also approved by the outstanding shares of stock, in accordance with Section 902 of the California Corporations Code.

5. The corporation has only a single class of shares and there were and are 15,000 shares of said common stock issued and outstanding, all of which were entitled to vote with respect to the approval of the amendment of the Articles of Incorporation.

6. Corporations Code Section 152 defines approval of the outstanding shares to mean the affirmative vote of a majority of the outstanding shares entitled to vote. Accordingly, the percentage vote required for approval of the outstanding shares entitled to vote was more than 50% thereof or at least 7,501.

7. The number of shares voting in favor of the amendment was 15,000 (or 100% of the outstanding shares), which exceeded the vote required.
