3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer said Patents or any patents, patent applications or other forms of protection based upon said Patents to Assignee, as assignee of the entire right, title and interest therein, or otherwise as Assignee may direct; and




