**RELEASE OF SECURITY INTEREST IN
PATENT COLLATERAL**

This RELEASE, dated as of June 5, 2007, is made by BARCLAYS BANK PLC, as Administrative Agent ("Barclays"), in favor of AMTROL INC. ("Amtrol") as follows:

WITNESSETH

WHEREAS, pursuant to the Security, Pledge and Guarantee Agreement between Amtrol and Barclays dated December 22, 2006 and the Patent Security Agreement, dated December 22, 2006 ("Patent Security Agreement"), Amtrol granted to Barclays a security interest ("Security Interest") in all right, title and interest of Amtrol in and to the Patent Collateral (as defined in the Patent Security Agreement and including, without limitation, the patents on Schedule A attached hereto). Capitalized terms used herein without definition are used as defined in the Security, Pledge and Guarantee Agreement and the Patent Security Agreement;

WHEREAS, the Patent Security Agreement was recorded with The United States Patent and Trademark Office on December 22, 2006 at Reel/Frame No. 018668/0412,

WHEREAS, Amtrol has requested that Barclays release its security interest in all right, title and interest of Amtrol in and to the patents and all applications therefor, technology and know-how, and all licenses, royalties and other monies relating thereto, set forth in Schedule A.

NOW, THEREFORE, Barclays, without recourse, representation or warranty and at Amtrol's sole cost and expense, hereby TERMINATES, RELEASES and DISCHARGES its Security Interest in the Patent Collateral, and any right, title or interest of Barclays in such Patent Collateral shall hereby cease and become void.

Barclays agrees to provide Amtrol with any information and additional authorization necessary to effect the release of such Security Interest.
