## IT IS AGREED as follows:

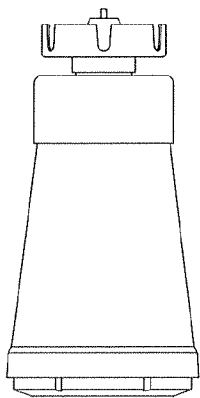

- This Assignment shall be governed by and construed in accordance with the laws of Hong Kong and the parties hereby submit to the non-exclusive jurisdiction of the courts of Hong Kong.

This Assignment has been entered into on the date stated at the beginning.

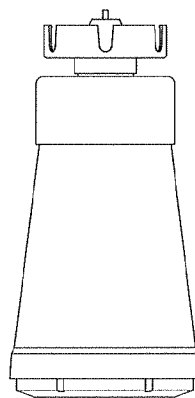

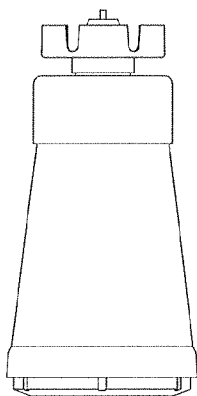

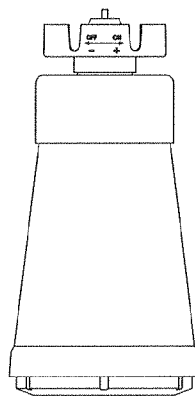

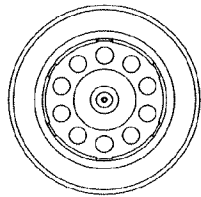

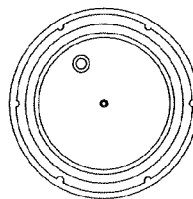

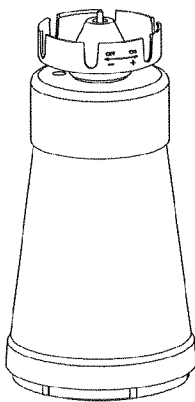
