

CERTIFICATE OF MERGER

Pursuant to the provisions of Title 8, Chapter 1, Subchapter IX, Section 251 of the Delaware General Corporation Law (the "Law"), the undersigned certifies the merger of a domestic corporation into a second domestic corporation, in accordance with the following:

1. The name and jurisdiction of incorporation of each of the constituent corporations which are to merge are:

- (i) AVAM International, Ltd., a Delaware corporation
- (ii) Novelos Therapeutics, Inc., a Delaware corporation

2. An agreement and plan of merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations which are to merge in accordance with applicable law.
