ASSIGNMENT

WHEREAS, ROY CLARK, of the city and state set forth below (hereinafter "Assignor") has invented certain new and useful inventions and improvements (hereinafter "Invention") described in the United States patent application entitled "DEVICE FOR IMPROVED ILLUMINATION EFFICIENCY," for which Assignor is making application for LETTERS PATENT OF THE UNITED STATES, which application has been duly executed by the Assignor concurrently herewith;

The Assignee will hold all rights for its own use and benefit and for the use and benefit of its successors or assigns to the full end of the term for which the LETTERS PATENT may be granted, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made. The Assignor requests and authorizes the Commissioner of the U.S. Patent and Trademark Office, and foreign counterpart officials of foreign patent offices, to issue respective LETTERS PATENT in the United States and foreign countries when granted, in accordance with this assignment.

The Assignor further covenants and agrees with the Assignee that Assignor has a full and unencumbered title to the Invention, which title Assignor warrants to the Assignee. Each Assignor further agrees that Assignor will, without demanding any further consideration therefor, at the request and expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining, extending, reissuing or reexamining United States and foreign LETTERS PATENT or the like for the Invention, and for maintaining and perfecting the Assignee's right to the Invention and LETTERS PATENT particularly in cases of interference conflict, opposition and litigation.
