said Patents to be held and enjoyed by the above-named ASSIGNEE, for ASSIGNEE's own use and benefit, and for ASSIGNEE's successors and assigns to the full end of the term or terms for which said Patents may be granted, as fully and entirely as the same would have been held by the undersigned ASSIGNOR had this assignment and sale not been made; and for the aforesaid consideration ASSIGNOR hereby covenants, agrees and undertakes to communicate to said ASSIGNEE or to its nominee all known facts respecting said invention(s), application(s) and patent(s), and to testify in any legal proceedings and to execute and deliver, whenever requested by the above-named ASSIGNEE, and without undue delay, all patent applications, assignments, lawful oaths and any other papers which ASSIGNEE may deem necessary or desirable for

securing to ASSIGNEE or for maintaining for ASSIGNEE all the invention(s), application(s) and patent(s) hereby assigned or agreed to be assigned all without further compensation to the undersigned ASSIGNOR.

AND it is hereby covenanted that ASSIGNOR has full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed and will not execute any agreement in conflict herewith.

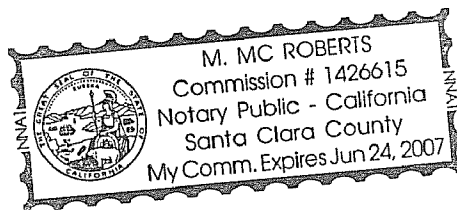
