ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, CHI-SHIN WANG, a citizen of the United States of America, ZHIKE JIA, a citizen of the Peoples Republic of China, LIANXUE XIONG, a citizen of the Peoples Republic of China, and YINGHAO TU, a citizen of Peoples Republic of China (hereinafter referred to as "ASSIGNORS"), have invented a certain invention entitled METHODS AND SYSTEMS FOR TEMPERATURE RELATED FRQUENCY DRIFT COMPENSATION for which application for Letters Patent of the United States of America was filed on March 2, 2007 and assigned Serial No. 11/681568; and

and equivalents to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNORS and that ASSIGNORS will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
