RELEASE OF SECURITY INTEREST ASSIGNMENT OF PATENTS

This Release of Security Interest Assignment of Patents dated as of February 10, 2006 ("Release"), is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent under the Third Amended and Restated Credit Agreement dated as of April 15, 2005 (as amended, restated or otherwise modified to date, the "Credit Agreement") among Digital Generation Systems, Inc., a Delaware corporation ("Digital"), the lenders from time to time party thereto and the administrative agent (in such capacity, "Administrative Agent") in favor of Digital and certain of its Subsidiaries party to the Security Assignment referred to below (collectively, "Debtors" with each being a "Debtor").




