And **EnviroSolv Energy LLC** further agrees to execute all necessary or desirable and lawful future documents as **Dennis W. Johnson and Mark S. Ehrnschwender** or their successors, assigns and legal representatives may from time-to-time present to it and without further remuneration, in order to perfect title in said inventions, modifications, and improvements in said inventions, applications and Letters Patent of the United States and countries foreign thereto.

And **EnviroSolv Energy LLC** further agrees to properly execute and deliver and without further remuneration, such necessary or desirable and lawful papers for application for foreign patents, for filing subdivisions of said applications for patent, and/or, for obtaining any reissue or reissues of any Letters Patent which may be granted for its aforesaid inventions, as **Dennis W. Johnson and Mark S. Ehrnschwender** shall hereafter require and prepare at their own expense.

ENVIROSOLV ENERGY LLC HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to **Dennis W.
