ARTICLES OF CONVERSION

The converted entity, M & M MANUFACTURING, L.P., will be liable for the payment of all fees and franchise taxes that have or will be assessed against the converting entity and/or the converted entity.

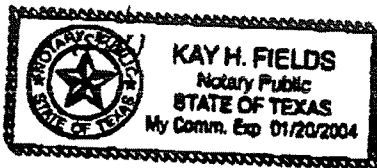

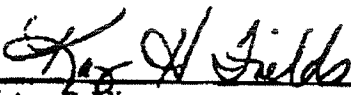
