## ASSIGNMENT

### **MOBILE COMMUNICATION SYSTEM HAVING RADIO ACCESS NETWORK AND METHOD CONTROLLING CALL PROCESSING LOAD THEREOF**

which claims priority to Korean Patent Application No. 10-2004-0109021, filed on December 20, 2004, and for which we are about to file an application for Letters Patent of the United States;




