In consideration of my agreement with the Assignee, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and/or in consideration

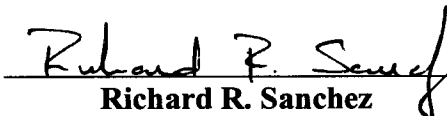
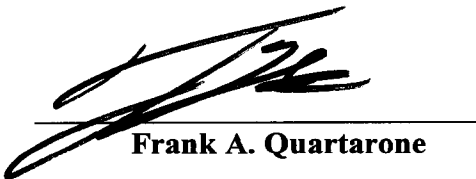
