AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

BRITESMILE, INC.

(Hereafter BSML, Inc.)

Pursuant to and in accordance with the provisions of Section 16-10a-1006 of the Utah Revised Business Corporation Act, as amended, (the "Act"), the undersigned, BriteSmile, Inc. (the "Corporation") hereby declares and certifies as follows:

1. The name of the Corporation is BriteSmile, Inc.
2. The text of the amendment to the Amended and Restated Articles of Incorporation of the Corporation adopted by Unanimous Written Consent of the Directors of the Corporation is as follows:

"ARTICLE I - NAME

The name of this corporation is BSML, Inc."

3. The amendment specified above does not provide for an exchange, reclassification, or cancellation of issued shares of the Corporation.
4. 
