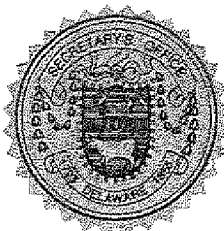

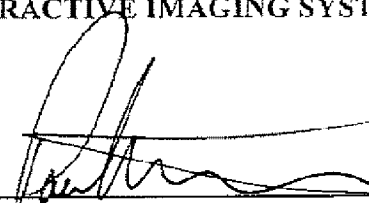
FIRST: The name of the Corporation is Vicuity Corporation
