### ASSIGNMENT

We hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said TECHNOLOGY PARTNERSHIP PLC, as the assignee of the entire right, title and interest in and to the same, for the sole use and behoof of the said TECHNOLOGY PARTNERSHIP PLC, its successors and assigns.

FURTHER, we agree that we will communicate to said TECHNOLOGY PARTNERSHIP PLC, or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said TECHNOLOGY PARTNERSHIP PLC, make all rightful oaths and generally do everything possible to aid said TECHNOLOGY PARTNERSHIP PLC its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.


