
ASSIGNMENT

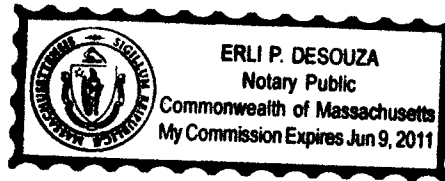

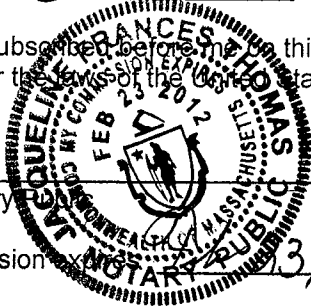
