
NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that the ASSIGNOR confirms its previous sale,

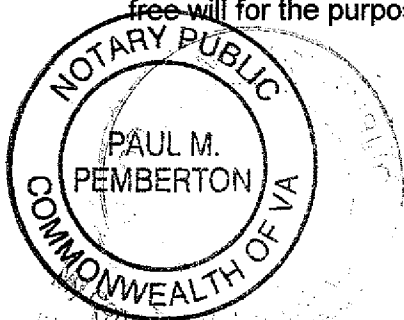
