**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT  
(WAI KOK SPORTS TO SPECIAL SPORTS BEHEER)**

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("Agreement"), effective as of the date of execution entered below, by and between WAI KOK SPORTS LTD., a company organized and existing under the law of Hong Kong ("Assignor" or "Wai Kok") herein duly represented by Mr. A.L.N. van der Meer by virtue of a validly existing power of attorney signed on behalf of Wai Kok Sports Limited by its managing director Chris Hall (see schedule "B"), and SPECIAL SPORTS BEHEER, B.V., a private company (*besloten vennootschap*) with limited liability (*beperkte aansprakelijkheid*) organized and existing under the laws of The Netherlands ("Assignee" ), herein duly represented by its managing director Mr. A.L.N. van der Meer.

WHEREAS, Assignor desires to assign to Assignee all of its worldwide right, title and interest in and to Intellectual Property (as hereinafter defined); and

WHEREAS, Assignee is desirous of acquiring any and all rights that Assignor may have throughout the world in and to Intellectual Property, and all applications and registrations therefor, together with the goodwill of the business in connection with which the Intellectual Property is used and which is symbolized by the Intellectual Property, throughout the world, along with the right to recover for damages and profits of any past, present, or future infringements thereof.

NOW, THEREFORE, for the monetary consideration stated in Article 2 herein, receipt of which the Assignor hereby acknowledges, the parties agree as follows:

1. For the purposes of this Agreement, "Intellectual Property" shall mean all (a) inventions (whether patentable or unpatentable and whether or not reduced to practice), all improvements thereto, and all patents (including utility and design patents, industrial designs and utility models), patent applications and patents and invention disclosures, and all other rights of inventorship, worldwide, together with all reissuances, continuations, continuations-in-part, divisions, revisions, supplementary protection certificates, extensions and re-examinations thereof (b) registered and unregistered trademarks, service marks, trade names, domain names, trade dress, logos and business, corporate and product names and slogans, worldwide, and registrations and applications for registration thereof, including all goodwill associated therewith; (c) copyrights in copyrightable works, and all other rights of authorship, worldwide, and all applications, registrations and renewals in connection therewith; (d) trade secrets and confidential business and technical information (including confidential ideas, research and development, know-

how, formulas, technology, compositions, manufacturing and production processes and techniques, technical data, engineering, production and other designs, plans, drawings, engineering notebooks, industrial models, software specifications, financial, marketing and business data, pricing and cost information, business and marketing plans and customer and supplier lists and information); (e) computer and electronic data, data processing programs, documentation and software, both source code and object code (including flow charts, diagrams, descriptive texts and programs, computer print-outs, underlying tapes, computer databases and similar items), computer applications and operating programs; (f) rights to sue for and remedies against past, present and future infringements of any or all of the foregoing and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide; (g) copies and tangible embodiments of any or all of the foregoing (in whatever form or medium, including electronic media); and (h) other proprietary, intellectual property and other rights relating to any or all of the foregoing.

2. For the monetary consideration of a market value to be determined later, provisionally determined at EUR 100,=, (in writing: one hundred Euro's) the receipt of which the Assignor hereby acknowledges, Assignor hereby grants, conveys and assigns to Assignee and Assignee herewith accepts the assignment, grant and conveyance of, by execution hereof (or, where appropriate or required, by execution of separate instruments of assignment), all of its worldwide right, title and interest in and to Intellectual Property, including without limitation the registrations and applications set forth on Schedule "A" hereto, to be held and enjoyed by Assignee, its successors and assigns.

3. Assignor further grants, conveys and assigns to Assignee all its right, title and interest in and to any and all causes of action and rights of recovery for past infringement of the Intellectual Property assigned herein.

4. Assignor further covenants that Assignor will, without demanding any further consideration therefor, at the request and expense of the Assignee (except for the value of the time of Assignor's employees), do all lawful and just acts that may be or become necessary for prosecuting, evidencing, maintaining, recording and perfecting the Assignee's rights to such Intellectual Property consistent with Assignor's general business practice, including but not limited to, execution and acknowledgment of assignments and other instruments in a form reasonably required by Assignee.

5. Assignor disclaims all warranties and representations of any kind relative to the validity or enforceability of any of the rights, title and interest in and to such Intellectual Property and the applications and registrations therefore assigned hereunder.

6. Assignor declares and confirms that it shall not at any time hereafter claim or purport to claim directly or indirectly in any manner whatsoever any right, title, interest into, over


7. This Agreement may not be assigned by Assignor, and any assignment in violation of this provision shall be void.



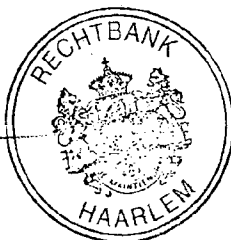

## POWER OF ATTORNEY

BY THIS POWER OF ATTORNEY made on 8 February 2006 WAI KOK SPORTS LIMITED whose registered office is 31/F., The Center, 99 Queen's Road Central, Hong Kong (hereinafter referred to as the "the Principal") hereby appoints Mr AUGUSTINUS LEONARDUS NICOLAAS VAN DER MEER as its attorney (the "Attorney") and in the Principal's name or otherwise and on its behalf:

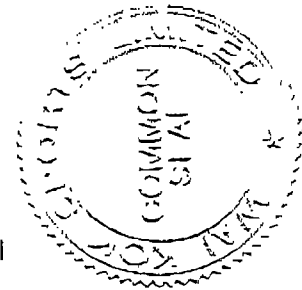
