AND ASSIGNOR hereby agrees, without requiring further remuneration, to execute any papers requested by ASSIGNEE, its successors, assigns and legal representatives, deemed essential by ASSIGNEE to ASSIGNEE's full protection and title in and to the intellectual property rights hereby transferred,

AND ASSIGNOR hereby covenants that ASSIGNOR have full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith.
