

## MICROEMISSIVE DISPLAYS GROUP PLC

#### BETWEEN:

- (1) MICROEMISSIVE DISPLAYS GROUP PLC, a company incorporated in Scotland with registration number SC272069 and having its registered office at Scottish Microelectronics Centre, West Mains Road, Edinburgh EH9 3JF (the "Company"); and
- (2) NOBLE VENTURE FINANCE I LIMITED a company incorporated under the laws of England having its registered office at 120 Old Broad Street, London, EC2N 1AR ("Noble").

### THIS DEBENTURE WITNESSES as follows:-

## 1. Definitions and Interpretation

- 1.1 In this Charge (including the Recitals), the following expressions shall, unless the context otherwise requires, have the following meanings:-
  - "Charged Property" means the undertaking and assets of the Company both present and future charged in favour of, or assigned (whether at law or in equity) to, Noble by or pursuant to this Charge;
  - "Claims" means all book and other debts and monetary claims referred to in Clause 3.1 or deriving from the Charged Property;
  - "Default Rate" means the rate per annum which is the aggregate of (a) 4 percent (4%) and (b) the base rate of the Bank of Scotland from time to time;
  - "Event of Default" means any event, howsoever described, specified in any of the Finance Documents or in this Charge as an event upon the occurrence of which Noble becomes entitled to call for early repayment of all or any of the Secured Obligations or to call for the provision of full or partial cash collateral in respect of any of the Secured Obligations which are at such time contingent or any failure by the Company to pay or repay on demand all or any of the Secured Obligations which are so payable;
  - "Facility Agreement" means the facility agreement dated on or about the date hereof between Noble and the Company as the same may from time to time be varied, amended or extended, reconstructed, substituted or replaced;
  - "Finance Documents" means the Financing Documents and the Security Documents and any other agreement, letter or document designated as a Finance Document by Noble and the Company;
  - "Financing Documents" has the meaning attributed to that term in the Facility Agreement;
  - "Fixed Charge Property" means the assets of the Company described in Clause 3.1(a);

have the exclusive right to appropriate any such payment or other sum in or towards the discharge of such part or parts of the Secured Obligations as Noble sees fit.

2.4 All payments to be made by the Company shall be made free and clear of and without deduction for or on account of any set-off, counter-claim or any present or future taxes, levies, imposts, duties, fees, deductions or withholdings of any nature whatsoever. If any deduction or withholding is required to be made from any such payment the Company shall pay to Noble such additional amount as will result in receipt by Noble of the full amount which would have been received if such deduction or withholding had not been made.

# 3. Charge

3.1 The Company with full title guarantee, as continuing security for the payment, performance and discharge of the Secured Obligations, hereby charges to Noble its obligations, title and interest in and to:-

all letters patent, trade marks, service marks, designs, utility models, copyrights, design rights, applications for registration of any of the foregoing and rights to apply for them in any part of the world, inventions, confidential information, know how and the rights of like nature arising or subsisting anywhere in the world in relation to any of the foregoing, whether registered or unregistered, now or at any time hereafter belonging to the Company (including, without limitation, any rights and interests of the Company in those patents and patent applications in the Schedule hereto) and the benefit of all licences and other rights to use such of the same charged in favour of, or assigned (whether at law or in equity) to, Noble by or pursuant to this Charge (the "Intellectual Property Rights"). To the extent that a fixed charge is not created hereunder over any of the Intellectual Property Rights, the charge thereof purported to be effected by this Clause 3.1(a) shall operate as an assignment of all such Intellectual Property Rights and any and all damages, compensation, remuneration, profit, rent or income which the Company may derive therefrom or be awarded or entitled to in respect thereof, as continuing security for the payment, discharge and performance of the Secured Obligations.

- 3.2 The charge hereby created shall be a fixed charge.
- 3.3 Notwithstanding anything herein to the contrary, (i) the Company shall remain liable under any contracts, agreements and other documents included in the Charged Property (to the extent set forth therein) to perform all of its duties and obligations thereunder to the same extent as if this Charge had not been executed, (ii) the exercise by Noble of any of the rights hereunder shall not release the Company from any of its duties or obligations under such contracts, agreements and other documents and (iii) Noble shall not have any obligation or liability under any such contracts, agreements or other documents included in the Charged Property by reason of this Charge, nor shall Noble be obligated to perform any of the obligations or duties of the Company thereunder or to take any action to collect or enforce any such contract, agreement or other document.
