RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

WHEREAS, pursuant to the Second Ranking Intellectual Property Security Agreement, recorded with the U.S. Copyright Office on May 24, 2005 at Reel/Frame No. 16216/0933, the Grantor granted the Tranche A Security Agent for the ratable benefit of the Tranche A Finance Parties a security interest in and to all of the Grantor's right, title and interest in, to and under all of its Intellectual Property, including the Copyrights, and proceeds of any and all of the foregoing;

WHEREAS, the Grantor has requested that the Tranche A Security Agent release its security interest in the Intellectual Property in connection with the termination of the Second Ranking Security Agreement and the Second Ranking Intellectual Property Security Agreement;

NOW, THEREFORE, in consideration of the foregoing, the Tranche A Security Agent hereby RELEASES, without recourse, all of its security interest in the Intellectual Property listed on <u>Schedule I</u> attached hereto and incorporated herein by reference (the "<u>Released Collateral</u>") to the Grantor.

The Tranche A Security Agent agrees to provide the Grantor with any additional authorization necessary to effect the release of its security interest in the Released Collateral.
