The constituent business corporations participating in the merger described in this Certificate (the "Merger") are Draeger Medical Infant Care, Inc., which is incorporated under the laws of the State of Delaware, and Draeger Medical, Inc., which is incorporated under the laws of the Commonwealth of Pennsylvania.

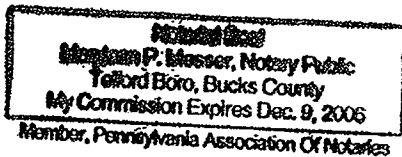
