ASSIGNMENT

WHEREAS, I, an inventor, **Maung Han**, a resident of 19145 Gramercy Place, Torrance, California 90501-1162, have invented certain new and useful improvements in **HIDDEN POINT DETECTION AND WARNING METHOD AND APPARATUS FOR NAVIGATION SYSTEM**, the application of which for a letter of patent is filed with the U.S. Patent and Trademark Office on March 29, 2007 and the assigned application number of which is 11/729,592;

AND I HEREBY covenant and agree that I will communicate to the said ASSIGNEE, his successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, his successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
