CONFIRMATORY PATENT ASSIGNMENT

It is agreed that the Assignors, both individually and collectively, shall be legally bound, upon request of the Assignee, or its successors or assigns or a legal representative thereof, to supply all information and evidence of which the Assignors have knowledge or possession, relating to the making and practice of said invention, to testify in any legal proceeding relating thereto, to execute all instruments proper to patent the invention in the United States of America in the name of the Assignee, and to execute all instruments proper to carry out the intent of this instrument.

The rights and property herein conveyed by the Assignors are free and clear of any encumbrance.
