THIS ASSIGNMENT is made the 21st day of June 2007

BETWEEN:

- (1) **Nicolai Wiest** of Frankfurt am Main, Germany (the "Assignor"); and
- (2) **Traxon Technologies Ltd.** having its address at Rooms 208 - 213, 2/F., Wireless Centre, 3 Science Park East Avenue, Hong Kong Science Park, Shatin, Hong Kong (the "Assignee").

WHEREAS:

- (A) The Assignor is the registered proprietor and beneficial owner of the design, particulars of which are set out in Part A of the attached Schedule (the "Design").
- (B) The Assignor has agreed to assign to the Assignee and the Assignee agrees to accept all such rights as the Assignor may have in the Design on the terms set out below.

NOW THIS AGREEMENT WITNESSES as follow:

1. In consideration of the fee paid by the Assignee (receipt of which is acknowledged by the Assignor), the Assignor hereby assigns as legal and beneficial owner to the Assignee:
 - (a) all such property, right, title and interest as it may have in the Design (including all common law rights connected therewith) together with all and any goodwill relating to any goods and/or services in respect of which the Design is registered;
 - (b) the right to claim to be the proprietor of the Design for the purpose of making further application(s) to register it as Design;
 - (c) the right to institute and maintain in its own name proceedings and recover damages in respect of any acts wheresoever or whensoever occurring which constitute infringement of the Design or passing off of the goodwill associated with the Design or any unfair competition in relation to the said goodwill or the Design,all of which to hold unto the Assignee absolutely.
2. The Assignor warrants that:
 - (a) the Design is legally and beneficially vested in the Assignor in order to enable it to carry out its obligations in this Assignment and that, to the best of its knowledge, no third party has any legal or other rights which would enable such third party to interfere with the use by the Assignee of the Design;
 - (b) the Assignor has not done or omitted to do any act or thing whereby the Design may have become encumbered or otherwise prejudicially affected;

- (c) the Assignor has not granted or agreed to grant any licence of the Design to any party other than the Assignee;
 - (d) the exploitation of the Design by or with the consent of the Assignee will not infringe any rights of any third party; and
 - (e) the Assignor will not from the date of this Assignment use the Design in any way except as is expressly authorised in writing by the Assignee.
3. The Assignor hereby covenants with the Assignee that it will, at the cost of the Assignee, execute any documentation or do any act or thing reasonably necessary or desirable for the purpose of giving effect to this Assignment or registering the Assignee as the registered proprietor of the Design.
4. This Assignment and its terms shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China and the parties agree to submit to the non-exclusive jurisdiction of the Hong Kong courts as regards any claim or matter arising in relation to this Assignment.
