Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other governments to issue all said Letters Patent to the said Assignee as assignee of the entire right, title and interest in and to the same, for the sole use and enjoyment of said Assignee, its successors and assigns.

issued to Assignee, make all rightful oaths and generally do everything necessary to aid said Assignee, its successors and assigns, to obtain and perfect title to said inventions in the United States and in any and all foreign countries.
