ASSIGNMENT AND CO-OWNERSHIP AGREEMENT

WHEREAS, George H. Tucker, having an address at 2004 SW 84th Terrace, N. Lauderdale, FL 33068, has invented certain new and useful improvements in TEA BREW BASKET, which is the subject of United States Patent No. 6,964,222 entitled TEA BREW BASKET;

WHEREAS, George H. Tucker is the sole owner of United States Patent No. 6,964,222 entitled TEA BREW BASKET;

WHEREAS, George H. Tucker and Denise F. Tucker, having an address at 2004 SW 84th Terrace, N. Lauderdale, FL 33068, are desirous to become co-owners of United States Patent No. 6,964,222 entitled TEA BREW BASKET for the express purpose that neither may transfer any interest or right to the invention, the patent application, or any patent or patents based thereon without approval of both;

WHEREAS, George H. Tucker and Denise F. Tucker (hereinafter referred to as the "Assignees") are desirous of acquiring co-owner rights in and to the application and are desirous of entering into an agreement restricting their ownership rights and George H. Tucker as sole owner (hereinafter referred to as "Assignor") is desirous of assigning the entire right, title and interest in and to said invention, and in and to said application and any Letters Patent that may issue thereon;

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor does hereby sell and assign to the Assignees so that they will be co-owners, their successors and assigns, all of Assignor's entire right, title and interest in and to the said invention and in and to the said application and all patents which may be granted therefor, and all divisions, reissues,

substitutions, continuations and extensions thereof; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom, insofar as his interest is concerned, to the Assignees.

Likewise, Assignor also hereby sells and assigns to the Assignees, their successors and assigns, his foreign rights to the invention disclosed in said application, in all patent-granting countries of the world, including the right to file applications and obtain patents for said invention in their own names in said countries and including all rights of priority in said countries under the terms of the International Convention for the Protection of Industrial Property, and Assignor further agrees to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

The Assignor also hereby agrees, at the request and expense of the Assignees, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said Assignees, their successors and assigns, to obtain and enforce proper patent protection for said invention in all countries.

The Assignor also hereby grant Robert C. Kain, Jr., Reg. No. 30,648 the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.

George H. Tucker and Denise F. Tucker hereby agree that they are co-owners of the patent rights that are the subject of this Assignment, that any future assignment, sale, or license (hereinafter referred to as a "disposition") of these patent rights must be with the written approval and consent of both co-owners, and that this Agreement makes any disposition by either of the co-owners without the express, written approval of the remaining co-owner void and null as a matter of law.

George H. Tucker and Denise F. Tucker hereby agree that if they both do not approve, in writing, of a disposition of the patent rights, then both co-owners will submit the dispute to binding arbitration which shall be conducted under the Rules of the American Arbitration Association by a single arbitrator, mutually agreed upon by both co-owners. The decision reached by the arbitrator as to the disposition of the patent rights shall be binding upon both co-owners.

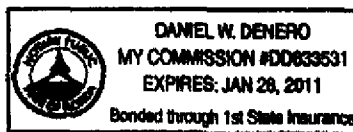
