WHEREAS, said Assignor has invented certain new and useful improvements in a: CHAIR set forth in an application for Letters Patent of the United States filed herewith.

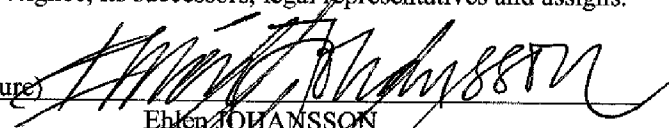

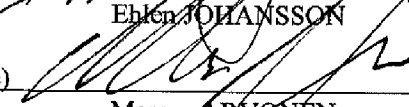
