We hereby authorize and request the Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation or reissue, to MOTOROLA, INC. and PURDUE UNIVERSITY, for the sole use and benefit of MOTOROLA, INC. and PURDUE UNIVERSITY, their successors, assigns and legal representatives, to the full end of the term for which Letters Patent may be granted, the same as they would have been held and enjoyed by me had

this assignment not been made, and we hereby authorize and request the equivalent authorities in foreign countries to issue the patents of their respective countries to MOTOROLA, INC. and PURDUE UNIVERSITY.

We covenant with MOTOROLA, INC., its successors, assigns and legal representatives and PURDUE UNIVERSITY, its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance.
