ASSIGNMENT OF INVENTION

WHEREAS I, Michael T. Goodrich, have invented certain new and useful improvements in an invention entitled: Efficient Authenticated Dictionaries with Skip Lists and Commutative Hashing, which was filed in the United States Patent Office on May 7, 2003 and accorded Application Serial No. 10/416,015; and


