ASSIGNMENT

WHEREAS I, **Jörg Bohlen** (the "Inventor"), residing Am Ritzeberg 7, 27607 Langen Germany, am the sole inventor of a design in **Folding Shade of Washi Fabric**, for which design a European Community Design Registration, no. 000583893-001, was filed on August 31, 2006, and I am entitled to assign my entire right, title and interest world-wide in and to the design and any intellectual property protection for the design, including the European Community Design Registration therefor; and

FURTHER I hereby authorize and request any official of any state, responsible for registering designs or other evidence or forms of any industrial property protection, to issue the same for the design to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO I hereby agree that I have the full right to convey my entire, right, title and interest in and to the design world-wide and all applications for industrial property protection for the design world-wide and that I have not executed, and will not execute, any agreement in conflict with this assignment.

MOREOVER I hereby agree that I will communicate to the Company, its successors, legal representatives and assigns any facts known to me respecting the design and testify in any legal proceeding, sign any lawful papers, execute any original, divisional, continuation and reissue applications, make any rightful oaths, and generally do everything possible to aid the Company, its successors, legal representatives and assigns to obtain and enforce proper protection for the design world-wide.

FURTHER I hereby agree that this assignment is to be considered effective as of the filing date of the European Community Design Registration.
