ASSIGNMENT

WHEREAS, WE, **JAMES D. TROLLOPE**, a citizen of the United States residing at 15432 Mountain View Lane, Frisco, Texas 75035; **BLAIR C. DUGGER**, a citizen of the United States residing at 12304 Alexandria Drive, Frisco, Texas 75035; **KENDALL L. YORN**, a citizen of the United States residing at 1015 Cross Plains Drive, Allen, Texas 75013; and **ALAN FLUDE**, a citizen of the United Kingdom residing at 8 Falcon Court, 11 City Garden Row, London, England N1 8EY (hereafter referred to as "ASSIGNORS"), have invented certain new, original and ornamental designs for a **BOTTLE** for which we have executed applications for Letters Patent of the United States assigned Serial No. 29/276,605 and Serial No. 29/276,604, each of which was filed on January 30, 2007; and

WHEREAS, DR PEPPER/SEVEN UP, INC. NOW, THEREFORE, in consideration of the sum of Ten Dollar (\$10.00) to us in hand paid, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, the said ASSIGNORS, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said inventions, and the said applications and all divisionals, continuations, and continuations-in-part thereof, and all rights of priority based thereon, and all Letters Patent of the United States which may be granted thereon and all reissues, renewals, reexaminations and extensions thereof, and all applications for Letters Patent which may have been or may hereafter be filed for said inventions in any country or countries foreign to the United States, and all Letters Patent which may be granted for said inventions in any country or countries foreign to the United States and all

extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said inventions to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

We HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

We HEREBY further covenant and agree that we will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said inventions, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said inventions in all countries.

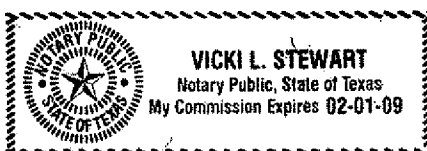

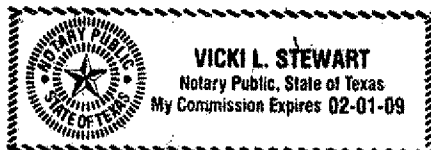


