


ASSIGNMENT BEFORE PATENT



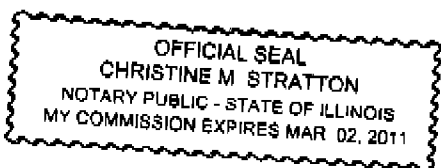
