ASSIGNMENT

WHEREAS, I, Min-Kyung LEE, a citizen of the Republic of Korea, residing at No. 503, Jiguchon, 527, Jinpyeong-dong, Gum-si, Gyeongsangbuk-do, Republic of Korea (hereinafter "ASSIGNOR"), have made a certain invention entitled "METHOD AND APPARATUS FOR AUTOMATICALLY CLASSIFYING FILES ON MOBILE COMMUNICATION TERMINAL" for which I am making application for Letters Patent of the United States, which application is being executed concurrently herewith; and

AND I HEREBY authorize and request the U.S. Patent and Trademark Office or other issuing authority to issue any and all patents on said invention and/or said applications to said ASSIGNEE as sole assignee;

AND I HEREBY covenant that I have the full right to convey the entire right, title and interest herein assigned and that I have not executed and will not execute any assignment or other instrument in conflict herewith;

AND I HEREBY further covenant and agree to communicate to said ASSIGNEE, or its legal representatives, successors or assigns, any facts relating to said invention, including evidence for interference purposes or other proceedings, whenever requested, and to testify in any interference or in any other legal proceeding, when requested, and to execute and deliver on request all lawful papers required to make any of the foregoing provisions effective; and to perform the aforesaid communicating, executing and delivering, without any payment except expenses and to perform the aforesaid testifying for reasonable compensation; and

generally to do everything possible to aid the said ASSIGNEE, its successors, legal representatives or assigns to obtain and enforce proper patent protection on and for said invention in the United States, and likewise I make these provisions binding upon our heirs, legal representatives and/or administrators.

I hereby grant the firm of Roylance, Abrams, Berdo & Goodman, L.L.P. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
