ASSIGNMENT AND AGREEMENT





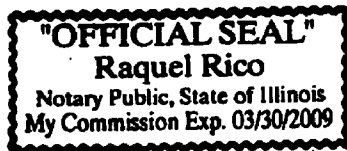
