Walbro Corporation further authorizes TI Group Automotive Systems, L.L.C. to apply for foreign patents on said invention in its own name or through its designees, including subsidiaries, related companies or assignees, under the International Convention or otherwise, and Walbro Corporation further agrees to execute all papers, including those required for the United States and foreign applications, and to perform such other proper acts as said company may deem necessary or proper to secure to said company or its designees the rights herein assigned.


