BETWEEN

- (1) **GE HEALTHCARE AS** (formerly AMERSHAM HEALTH AS) (trading as GE Healthcare) a company incorporated under the laws of Norway formerly called Nycomed Imaging AS whose principal office is at Nycoveien 1-2, P.O. Box 4220, Nydalen, N-0401, Oslo, Norway and whose address for service in the United Kingdom is at Amersham Place, Little Chalfont, Amersham, Bucks HP7 9NA ("the Licensor"); and
- (2) **OXFORD INSTRUMENTS MOLECULAR BIOTOOLS LIMITED** (registered no. 5004981) whose registered office is at Old Station Way Eynsham Witney Oxfordshire OX29 4TL ("the Licensee")

WHEREAS

- (A) The Licensor is the registered proprietor of the Patents and is entitled to the benefit of the Patent Applications listed in the Schedule attached hereto ("the Patents and Patent Applications")
- (B) By an Agreement ("the Main Agreement") dated 7 April 2004 and made between Amersham PLC (the parent company and acting inter alios on behalf of the Licensor) and Oxford Instruments Superconductivity Limited the Licensor granted a licence under the Patents and the Patent Applications and certain know-how therein specified on the terms and for the consideration set out in the Main Agreement and agreed to execute this Licence
- (C) Oxford Instruments Superconductivity Limited with the consent of the Licensor has assigned to the Licensee the entire benefit of the Main Agreement and has requested the Licensor to grant this Licence to the Licensee

NOW IT IS AGREED that:**1. GRANT OF LICENCE**

In pursuance of the Main Agreement and for its share of the consideration referred to therein the Licensor hereby grants to the Licensee the exclusive worldwide right and licence under the Patents and the Patent Applications listed in the Schedule (including right and licence under all patents granted pursuant to such patent applications and all corresponding national and regional phase applications and all divisions, continuations, reissues and re-examinations thereof which may be granted) and certain related know-how to develop, make, have made, market, import, use, sell, lease or otherwise commercialise Licensed Products for in vitro analysis (other than the design, development or manufacture of chemical agents)

2. TERMS OF LICENCE

The primary terms specified in the Main Agreement are:

- 2.1 the consideration referred to comprises an initial payment by the Licensee, the payment of a royalty at a percentage of Net Sales of Licensed Products by the Licensee, its affiliates and sub-licensees and a percentage of any royalty premiums or capital payments received by the Licensee from any sub-licensee;
- 2.2 the Territory is each and every country in the world;
- 2.3 the Licensee has a defined right to sub-licence

3. **RIGHTS OF ACTION**

The licence hereby granted confers upon the Licensee with effect from the date of the Main Agreement certain powers and rights of action in respect of infringements of the Patents and the Patent Applications

4. **TERMINATION**

This Licence shall continue until, and shall determine without notice in the event of, termination of the Main Agreement, which continues in force until the expiry of the last to expire of all the patents and patent applications therein referred to or the earlier occurrence of certain events of termination

5. **STATUS OF THIS AGREEMENT**

This Agreement is granted in pursuance of the Main Agreement and not in addition thereto or in substitution therefor and nothing herein contained shall in any way derogate from the Main Agreement or extend the rights thereby granted The Licensor affirms the provisions of the Main Agreement therein undertaken by Amersham plc. Save as otherwise specifically provided herein, the definitions in the Main Agreement shall apply in this Licence

6. **LAW AND PROCEEDINGS**

This Agreement shall be governed by and construed in accordance with the laws of England and the parties irrevocably submit to the exclusive jurisdiction of the courts of England


