ASSIGNMENT OF APPLICATION FOR PATENT

WHEREAS, we, Rainer Hoefer, Laurence Druene, Jean-Marc Ballin and Morgan Garinet, citizens of France, with the exception of Rainer Hoefer, who is a citizen of Germany, and residents of Klever Strasse 31, 40477 Duesseldorf, Germany; 20, rue Louis Rodier, 77930 Perthesen Gatinais, France; 88 bis rue de la Republique, 93160 Noisy le Grand, France; and 3, allée des bois, 77000 Vaux le Penil, France; respectively, have invented certain new and useful improvement in RADIATION CURABLE COMPOSITIONS for which we have made application for United States Letters Patent, said application having been filed as PCT international application number PCT/EP2005/012147 on November 12, 2005 designating the United States of America and various other countries; and

AND, we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may issue upon said invention to said CIPM and CFR as assignees of the entire right, title and interest in and to said invention, said application and any and all Letters Patent that may issue thereupon.


