patent issuing thereon, including past infringement prior to Assignee's acquisition of these rights, together with the right to sue for, in Assignee's own name, and collect damages for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives;

Assignor hereby covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this assignment and sale;

Assignor further covenants and agrees that, upon Assignee's request, Assignor will promptly provide Assignee, at any time, upon request, with all pertinent facts and documents relating to said invention and said Patent Application as may be known and accessible to Assignor, and will testify as to the same in any interference, litigation, or other legal proceeding related thereto, and will promptly execute and deliver to Assignee or its legal representative any and all papers, instruments, or affidavits, make all rightful oaths or declarations, and do all lawful acts requisite, required to apply for, revive, reinstate, reissue, disclaim, obtain, maintain, and enforce said invention and said (Pending) Patent which may be necessary or desirable to carry out the purposes hereof;

Assignor authorizes and requests the Commissioner of Patents of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid; to issue and assign said Patent Application which may issue on said invention, included in the subject matter of said Patent Application, to Assignee, its successors, and assigns, as the Assignee has the entire right, title, and interest in and to the same, for the sole use and enjoyment of said Assignee, its successors, and assigns.

This Assignment shall be governed by, and construed, interpreted, and enforced in accordance with the laws of the State of Ohio, without regard to conflict of laws principles.
