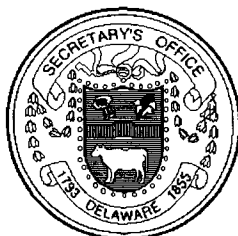


First: That by unanimous written consent, the Board of Directors of the Corporation has adopted the following resolution:
