

345 Converting a cooperative society to a company

- (a) A Registered Cooperative Society (in this clause society) which wishes to be registered as a company will prepare a plan for its organization as a company and submit it for the approval of Cooperative Societies Registrar within the meaning of the Cooperative Society Ordinance.
- (b) The Minister, in consultation with the Minister of Labor and Welfare, may stipulate conditions according to which the Cooperative Societies Registrar may approve the plan submitted to him in accordance with the provisions of sub-clause (a), including conditions whose purpose is to ensure that the position of the Society's creditors will not worsen.
- (c) Should the Cooperative Societies Registrar approve the plan, the plan will be brought for approval to the Society's General Meeting for which notice of 21 days in advance was given as required by law, in which the details of the plan were presented; should the plan be passed by a majority of at least three quarters of the members entitled to vote and who voted themselves or by a proxy, articles will be prepared in accordance with this Law and on submitting the application for registration, a copy of them will be submitted to the Registrar of Companies and the fees, as determined by the Minister, will be paid.
- (d) Should the Registrar of Companies approve the registration, he will inform the Cooperative Societies Registrar of this and he will cancel the registration of the Cooperative Society and publish a notice of this in the Government Gazette; after cancellation the Registrar of Companies will register the Society as a company.
- (e) On registration of the Society as a company the Cooperative Societies Registrar will send the Registrar of Companies an extract of all the entries in the Register of Liens relating to the liens that the Society registered prior to its registration as a company, and which were in existence at the time of the registration and all the documents he holds which created these liens or which prove them, and the Registrar of Companies will register the liens and details in the extract relating to every lien, without any fees.
- (f) All the assets and liabilities, including known and unknown liabilities, existing and contingent, of the Society will be transferred on registration to the Company, and all the legal proceedings in which the Society was a party will continue in such a way that the Company will be the party to such proceedings
