## **ASSIGNMENT**

Further, I agree that WE will communicate to said ASSIGNEE or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all papers relating to all divisional, continuation, continuation-in-part, extension, renewal, non-provisional or substitute thereof, and any renewal, re-examination and reissue of said Letters Patent, execute all necessary assignment papers to cause any and all of said Letters Patents to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in any and all countries.
