## SECURITY INTEREST IN PATENTS

THIS SECURITY INTEREST IN PATENTS ("Security Interest In Patents"), dated as of August 3, 2007, is made by Enefco USA, Inc., a Delaware corporation ("Grantor"), in favor of Bank of America, N.A., as lender under the Security Agreement described below ("Bank").

WHEREAS, pursuant to that Credit Agreement dated August 3, 2007, entered into by Grantor, Bank and certain other parties (the "Credit Agreement"), certain loans and credit facilities are to be made available to Grantor and certain of its affiliates;

WHEREAS, in connection with the Credit Agreement, Grantor has executed and delivered to Bank a Security Agreement of even date herewith (together with all amendments and other modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), pursuant to which the Grantor has granted a security interest in the Collateral (as defined therein) to the Bank;

WHEREAS, as a condition precedent to the making of the loans and the establishment of the credit facilities under the Credit Agreement, and in conjunction with the Security Agreement, Grantor is required to execute and deliver this Security Interest In Patents;

WHEREAS, Grantor has duly authorized the execution, delivery and performance of this Security Interest In Patents; and

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Grantor agrees as follows:

Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Security Interest In Patents, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or the Credit Agreement (collectively, the "Finance Documents").

Grant of Security Interest. As security for the full and timely payment, observance and performance of the obligations pursuant to the Finance Documents, Grantor hereby grants to Bank a continuing security interest in all of Grantor's right, title and interest in the Patents' (including, without limitation, those items listed on Schedule A hereto).

Purpose. This Security Interest In Patents has been executed and delivered by Grantor for the purpose of registering with the United States Patent and Trademark Office ("PTO") the grant of a security interest in the Finance Documents. The security interest granted hereby has been granted, pursuant to Clause 7(b) of the Security Agreement, as a supplement and ancillary to, and not in limitation of, the security interest granted to Bank under the Security Agreement. The Security Agreement (and all rights and remedies of Bank thereunder) shall remain in full force and effect in accordance with its respective terms. In the event of any conflict between this Security Interest in Patents and the Finance Documents, the Finance Documents shall prevail.

Acknowledgement. Grantor does hereby further acknowledge and affirm that the rights and remedies of Bank with respect to the security interest in the Patents granted hereby are more fully set forth in the Finance Documents, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.



Counterparts. This Security Interest In Patents may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


