## ASSIGNMENT

**I, one of the persons named below, hereby state and agree as follows:**

I have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **CONSTELLATION-MULTIPLEXED TRANSMITTER AND RECEIVER**, and executed by me on even date herewith and with claim to the priority of United States Patent Application No. 09/430,466, filed October 30, 1998 and with claim to the priority of United States Provisional Application No. 60/106,481, filed October 30, 1998;




