

Product Rights Sales Agreement


This Product Rights Sales Agreement (The "Agreement") is entered into this day of February 1, 2006 between: Multivideo Labs Inc (hereinafter known as "MVL"), a USA corporation with its principal place of business at 31 Airpark Road, 1st Floor, Princeton, NJ 08540, and Topshine Electronics Corp. (hereinafter known as "Topshine"), a corporation with its principal place of business at 5F, NO.68 CHOU-TEZ ST., NEIHU DIST. NEIHU DIST. 114 TAIPEI, TAIWAN

Whereas MVL and Topshine have an existing agreement for profit sharing of TH2000 ASIC and related products based on the ASIC, dated May 1, 2000, the parties hereby agreed to terminate said agreement as of January 1, 2006. For a fixed final payment of \$50,000 from Topshine to MVL (payable in 2 installments of \$25,000, due in March 31, 2006 and September 30, 2006), Topshine shall thereafter own the complete worldwide right to the products without profit sharing with MVL. Further, in consideration of said payment, MVL agrees to transfer the assignment of U.S. Patent # 6,363,085, titled Universal Serial Bus Repeater at no cost to Topshine. Should Topshine elect to make such a transfer on record with the U.S. Patent Office, Topshine shall have bear the bookkeeping expenses and fees for the transfer.

The parties agree that this Product Rights Sales is binding upon execution, and not contingent upon amount of future sales after January 1, 2006.
