Assignor hereby requests the U.S. Patent and Trademark Office to recognize Assignee as owner, applicant, or patentee with the full right to transact all business, conduct all prosecution regarding said patents or applications.

Upon request, Assignor will have any documents executed or cause its representatives to appear and testify in any proceeding that may be necessary to secure title of said patents and patent applications in Assignee.
