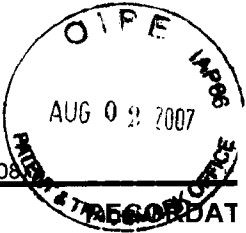

## ASSIGNMENT

and in and to any divisions, continuations, continuations-in-part and extensions of any said Regular Applications.

AND FOR THE SAME CONSIDERATION the Assignor agrees that it will, without further consideration, do all such things and execute all such documents as may be necessary or desirable to obtain and maintain patents for said invention and for additions and modifications thereto in any and all countries, and to vest title thereto in said Assignee, its successors, assigns, and legal representatives or nominees.

AND FOR THE SAME CONSIDERATION the Assignor authorizes and empowers said Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said invention or for additions and modifications thereto, filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from the Assignor.

The Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks to issue said Letters Patent to said Assignee, the Assignee of the entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by the Assignor had this assignment and sale not been made.


