ASSIGNMENT

WHEREAS, We, Stephane Monfray, a resident of Grenoble, France, and citizen of France, Thomas Skotnicki, a resident of Crolles-Montfort, France, and citizen of France, Didier Dutartre, a resident of Meylan, France, and citizen of France and Alexandre Talbot, a resident of Grenoble, France and citizen of France have invented certain new and useful improvements in "TRANSISTOR WITH A CHANNEL COMPRISING GERMANIUM" disclosed in an application for United States Letters Patent (Application No. 11/725,160, filed March 16, 2007);

WHEREAS, STMicroelectronics SA, a corporation organized under the laws of the country of France, having a place of business at 29, boulevard Romain Rolland, 92120 Montrouge, France and STMicroelectronics (Crolles 2) SAS a corporation organized under the laws of the country of France, having a place of business at 850, rue Jean Monnet, 38920 Crolles, France (hereinafter referred to as "ASSIGNEES"), is desirous of acquiring our entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon;

Munck, or Daniel E. Venglarik of Munck Butrus, P.C. to insert in the parenthesis above the application number and filing date of said application when known; and we hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom, insofar as our interest is concerned, to the said ASSIGNEES of our entire right, title and interest.

We also hereby sell and assign to said ASSIGNEES, their successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in their own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and we further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEES, their successors, assigns and legal representatives.

We hereby further agree that we will communicate to said ASSIGNEES, or to their successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEES, to testify in any legal proceedings, sign all lawful papers,

execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEES and to aid said ASSIGNEES, their successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
